[Editor's note: Thank you Paul, especially for not saying "yeoperson."]



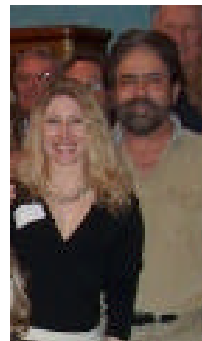
As in previous years, much of the Club's success is a result of the dedication and expertise of our Cellar Master, Steve Pitcher, to whom LFW will be indebted for years to come.

## 11th Annual German Wine Tasting at German Consulate

At our *Harvest Moon* event at Nickel & Nickel, we had, what else, a glorious Harvest Moon. At our *Wine Tasting 101* event in the Bayview Room at the World Trade Club, we had a total lunar eclipse.

So perhaps our attending LFW members weren't too surprised when a magnificent thunder and lightening storm crackled and roared to set the stage for this vintage Pacific Heights San Francisco night of wine tasting.

Those who arrived early could peek in to find German Wine Society President (and our very own LFW cellar master) Steve Pitcher preparing more than 100 estate-bottled wines – mostly Rieslings – from Germany's remarkable, historic harvest of 2003 for this festive, taste-full event.

Twenty members of Lawyer Friends of Wine and their companions joined members of the German Wine Society and other invited guests, including members of The City's Consular Corps, at the Society's *11th Annual New Vintage Tasting* at the German Consulate in San Francisco's on February 18th.



The pour-your-own vintage sample wines were lined up two rows per table on two long tables to allow sipping at the taster's own pace.

The offerings ranged from exquisite examples of dry Rieslings (from specialists in this field in Germany) to off-dry (halb trocken) and QbA Rieslings, and a grand diversity of Kabinett, Spätlese, Auslese and Beerenauslese Rieslings, finishing with Eiswein.

Our detailed wine taster's programs listed each of the 117 wines by number (which corresponded to number tags on the bottles) to enable even those most unfamiliar with these wines to easily identify what was being sampled and its retail price.



Before our first sip, as we stood near the beautiful circular stairway of the consulate

(a fine old Matson family mansion) we learned from German Wine Society President (and LFW cellar master) Steve Pitcher that the 2003 growing season was the warmest and driest in modern German history, resulting in "opulently rich wines in all categories. There were few true Kabinetts in 2003," Pitcher noted, "as most are really the producers' 'smallest' Spätlese or Auslese. These represent the greatest values for the budget-minded shopper."

"The higher-Prädikat wines – Auslese and Beerenauslese – were lusciously sweet, yet balanced by wonderfully ripe, crisp acidity. Because of the warm, dry conditions, most were unaffected by botrytis, a beneficial mold that usually shows up in grapes harvested for dessert-style Riesling in Germany. Instead, they were super-ripe, healthy, late-harvest grapes that yielded nectar-like wine that will mature for years in a good cellar."
